THIS PERMIT IS HEREBY ISSUED TO

to use the waters of AN UNNAMED STREAM, a tributary of WILLAMETTE RIVER, for SUPPLEMENTAL IRRIGATION OF 44.4 ACRES AND MAINTENANCE OF BRYANT WILDLIFE RESERVOIR, to be constructed under Application R-70198, Permit R-11473, for WILDLIFE.

This Permit is issued approving Application 70370. The date of priority is May 21, 1990. The use is limited to not more than 0.66 CUBIC FOOT PER SECOND (CFS), BEING 0.56 CFS FOR IRRIGATION AND 0.10 CFS FOR WILDLIFE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 5, T 4 S, R 2 W, W.M.; 2985 FEET NORTH AND 90 FEET WEST FROM S 1/4 CORNER, SECTION 5.

In the interest of conserving groundwater, this permit may be exercised to satisfy the primary right provided that the total quantity of water diverted from all sources does not exceed ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

Actual construction work shall begin on or before December 4, 1993, and shall be completed on or before October 1, 1995. Complete application

of the water to the use shall be made on or before October 1, 1996.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
