PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of WILSON RESERVOIR, CONSTRUCTED UNDER APPLICATION R-73432, PERMIT R-11493, a tributary of LUCKIAMUTE RIVER, for IRRIGATION OF 180 ACRES.

This permit is issued approving Application 73433. The date of priority is JUNE 4, 1993. The use is limited to not more than 150 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 13, T 9 S, R 6 W, W.M.; 2800 FEET NORTH AND 1500 FEET WEST FROM THE SE CORNER OF ANDREW J. WELCH DLC 41.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to 2.5 acre-feet for each acre irrigated during the irrigation season of each year from stored water only.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

NW 1/4 NE 1/4	1.0 ACRES
SW 1/4 NE 1/4	26.0 ACRES
SE 1/4 NE 1/4	15.5 ACRES
NE 1/4 SW 1/4	5.0 ACRES
SE 1/4 SW 1/4	24.0 ACRES
NE 1/4 SE 1/4	18.0 ACRES
NW 1/4 SE 1/4	38.0 ACRES
SW 1/4 SE 1/4	37.0 ACRES
SE 1/4 SE 1/4	15.5 ACRES

SECTION 13

TOWNSHIP 9 SOUTH, RANGE 6 WEST, W.M.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

Actual construction work shall begin on or before July 29, 1995, and shall be completed on or before October 1, 1996. Complete application of the water to the use shall be made on or before October 1, 1997.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Commission found the proposed use(s) of water described by this permit, as conditioned, would not impair or be detrimental to the public interest at its July 22, 1994 Commission meeting.
