THIS PERMIT IS HEREBY ISSUED TO

to use the waters of HOT LAKE DRAINAGE DITCH (EAST AND WEST BRANCH), AND UNNAMED STREAM (EAST AND WEST BRANCH) TRIBUTARIES OF CATHERINE CREEK TO PROVIDE WETLAND HABITAT FOR WILDLIFE BY MAINTAINING 10 RESERVOIRS TO BE CONSTRUCTED UNDER APPLICATION R-69563, PERMIT R-11512.

This permit is issued approving Application 69135. The date of priority is JUNE 15, 1987. The use is limited to not more than 2.5 CUBIC FEET PER SECOND (CFS), BEING 1.75 CFS FROM HOT LAKE DRAINAGE DITCH (EAST AND WEST BRANCH) FOR MAINTAINING RESERVOIRS 4 THROUGH 10 AND 0.75 CFS FROM UNNAMED STREAM (EAST AND WEST BRANCH) FOR MAINTAINING RESERVOIRS 1 THROUGH 6, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RESERVOIR 1 - SE 1/4 SE 1/4, RESERVOIR 2 - NE 1/4 SE 1/4, RESERVOIR 3 AND 4 - NW 1/4 SE 1/4, RESERVOIR 5 AND 6 - NE 1/4 SW 1/4, RESERVOIR 7. 8, 9 AND 10 - NW 1/4 SW 1/4, ALL IN SECTION 32, TOWNSHIP 3 SOUTH, RANGES 39 EAST, W.M.

The period of allowed use is March 1 through October 31.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information including the place and nature of use of water under the permit.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

Actual construction work shall begin on or before DECEMBER 20 , 1995, and shall be completed on or before October 1, 1996. Complete application of the water to the use shall be made on or before October 1, 1997.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of besupractical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director of the Water Resources Department has found that the proposed use of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.
