PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of SURFACE RUNOFF AND OLD TILE DRAINFIELD, a tributary of CHEHALEM CREEK, for MAINTENANCE OF SIX RESERVOIRS constructed under Application R-73303, PERMIT R-11530, for WILDLIFE HABITAT.

This permit is issued approving Application 73304. The date of priority is MARCH 26, 1993. The use is limited to not more than 0.44 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. The use of water for wildlife habitat is limited to the period of November 1 through April 30 of each year. No live flow can be used between June 1 and October 31.

During the period of June 1 through October 31 of each year, use under this permit is limited to the reservoir area. This permit does not provide for the appropriation of water for maintaining the water level or maintaining a suitable fresh water condition.

The point of diversion is located as follows:

DIV 1 - NW 1/4 SE 1/4, TOWNSHIP 3 SOUTH, RANGE 3 WEST, SECTION 19, W.M.; 3173 FEET SOUTH AND 1466 FEET WEST, DIV 2 - NW 1/4 SE 1/4, 2805 FEET SOUTH AND 2295 FEET WEST, BOTH BEING FROM THE NE CORNER OF SECTION 19.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

6 PONDS IN THE NW 1/4 SE 1/4 (MAINTENANCE ONLY)  
SECTION 19  
TOWNSHIP 3 SOUTH, RANGE 3 WEST, W.M.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

Actual construction work shall begin on or before JANUARY 13, 1996 and shall be completed on or before October 1, 1997. Complete application of water shall be made on or before October 1, 1998.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director of the Water Resources Department has found that the proposed use of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.
