THIS PERMIT IS HEREBY ISSUED TO

to use the waters of MULTNOMAH CHANNEL, GILBERT RIVER AND THE NARROWS, tributaries of COLUMBIA RIVER AND WILLAMETTE RIVER, for MAINTAINING FOR RECREATIONAL PURPOSES INCLUDING WILDLIFE AND FISHERIES LAKES MANAGEMENT.

This permit is issued approving Application 71062. The date of priority is DECEMBER 20, 1990. The use is limited to not more than 22.3 CUBIC FEET PER SECOND (CFS), BEING 4.5 CFS FROM MULTNOMAH CHANNEL, 8.9 CFS FROM GILBERT RIVER AND 8.9 CFS FROM THE NARROWS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:.

SW 1/4 SW 1/4, SECTION 9, T 3 N, R 1 W, W.M.; 610 FEET NORTH AND 1200 FEET EAST FROM THE SW CORNER OF SECTION 9.

SE 1/4 SE 1/4, SECTION 9, T 3 N, R 1 W, W.M.; 720 FEET NORTH AND 920 FEET WEST FROM THE SE CORNER OF SECTION 9.

NE 1/4 NW 1/4, SECTION 21, T 3 N, R 1 W, W.M.; 1020 FEET SOUTH AND 1860 FEET EAST FROM THE NW CORNER OF SECTION 21.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

Measurement, recording and reporting conditions:

Before water use may begin under this permit, permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.

B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

Actual construction work shall begin on or before April (2, 1996 and shall be completed on or before October 1, 1998. Complete application of water shall be made on or before October 1, 1999.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The Water Resources Commission has found that the proposed use of water described by this permit, as conditioned, will not impair or be detrimental to the public interest on April 6, 1995.
