PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

SANDY FARMS, INC
34500 SE HWY 211
BORING, OREGON 97009

The specific limits for the use are listed below along with conditions of use.

APPLICATION FILE NUMBER: S-70777

SOURCE OF WATER: Unnamed stream and stored water from reservoirs 1, 1A, 3 and Deep Creek reservoir.

PURPOSE OR USE: Irrigation of 32.4 acres.

MAXIMUM FLOW/VOLUME ALLOWED: 0.405 CFS and stored water.

PERIOD OF USE: The period of allowed use is live flow from March 1 to April 30 and October 1 to October 31; stored water only from reservoirs 1, 1-A, 3 and Deep Creek from March 1 to October 31.

DATE OF PRIORITY: October 16, 1990

POINTS OF DIVERSION LOCATION:

NW 1/4 NE 1/4, SE 1/4 NE 1/4, NE 1/4 SE 1/4, Section 21, NE 1/4 NE 1/4, Section 27, T 2 S, R 4 E, W.M.; POD 1 (RESERVOIR 1) - 198 FEET S & 383 FEET W from E 1/4 corner, Section 21; POD 2 (RESERVOIR 1-A) - 2730 FEET N & 500 FEET W from SE corner, Section 21; POD 3 (RESERVOIR 3) - 75 FEET S & 1620 FEET W from NE corner, Section 21; POD 4 (UNNAMED TRIBUTARY OF DEEP CREEK) - 1240 FEET S & 4550 FEET E from SE corner, Section 21 ; POD 5 (DEEP CREEK RESERVOIR) - 1240 FEET S & 950 FEET W from NE corner, Section 27.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NW 1/4 NE 1/4 32.4 ACRES
Section 21
TOWNSHIP 2 SOUTH, RANGE 4 EAST, W. M.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee shall install, maintain, and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion. The required screen is to be in place and functional prior to diversion of any water.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.


This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin within one year from permit issuance and shall be completed on or before October 1, 1997. Complete application of the water to the use shall be made on or before October 1, 1998.
