SOURCE OF WATER: NORTH UMPQUA RIVER, TRIBUTARY OF UMPQUA RIVER

PURPOSE OF USE: DOMESTIC EXPANDED FOR ONE HOUSEHOLD

MAXIMUM FLOW/VOLUME ALLOWED: 0.01 CFS

PERIOD OF USE: The period of allowed use is year round. However, during the period July 1 to October 31 of each year use is restricted to human consumption including irrigation of a non-commercial garden not to exceed 1/2 acre in area.

DECEMBER 22, 1993 DATE OF PRIORITY:

POINT OF DIVERSION LOCATION: SE 1/4 NE 1/4, SECTION 9, T 26 S, R 3 W, W.M.; 30 FEET NORTH AND 980 FEET WEST OF THE EAST 1/4 CORNER OF SECTION 9, CLARA WOOD SUBDIVISION.

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NE 1/4 SE 1/4 SECTION 9 TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

Measurement recording and reporting conditions:

The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device.

Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee may be required to install, maintain, and operate a fish screening device which meets or exceeds the requirements of the Oregon Department of Fish & Wildlife to prevent fish from entering the proposed diversion. The required screen is to be in place and functional prior to diversion of any water.

In the event of a request for a change in point of appropriation, an additional point of appropriation or alteration of the appropriation facility associated with this authorized diversion, the quantity of water allowed herein, together with any other right, shall not exceed the capacity of the facility at the time of perfection of this right.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin on or before October 17, 1996, and shall be completed on or before October 1, 1997. Complete application of the water to the use shall be made on or before October 1, 1998.

This permit is issued to correctly describe the dates for beginning and completion of construction, and complete application of the water to the use allowed herein. Permit 51709 is superseded by this instrument and is of no further force or effect.
