PURPOSE OR USE: AGRICULTURAL USE (NURSERY OPERATIONS) ON 78.50 ACRES

RATE/VOLUME: 10.35 ACRE-FEET, BEING 1.25 ACRE-FEET FROM RESERVOIR #1 AND 9.10 ACRE-FEET FROM RESERVOIR #2, STORED WATER ONLY YEAR ROUND

PERIOD OF ALLOWED USE: THE USE OF STORED WATER IS ALLOWED ALL YEAR FOR BENEFICIAL USE

DATE OF PRIORITY: APRIL 25, 1991

POINT OF DIVERSION (POD) LOCATION: SE 1/4 NW 1/4, SECTION 35, T1S, R4E, W.M.; POD #1 - NORTH 7 DEGREES 18 MINUTES 47 SECONDS 970 FEET WEST; POD #2 - NORTH 30 DEGREES 12 MINUTES 50 SECONDS 1122 FEET WEST, BOTH FROM THE C 1/4 CORNER OF SECTION 35

The amount of water used for NURSERY OPERATIONS is limited to a diversion of 0.15 cubic foot per second per acre. For the irrigation of containerized nursery plants, the amount of water diverted is limited to ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre feet per acre per year. For the irrigation of in ground nursery plants the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre per year. The use of water for NURSERY OPERATIONS may be made at anytime of the year that the use is beneficial. For the irrigation of any other crop, the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre during the irrigation season of each year.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee shall install, maintain, and operate fish screening devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion. The required screens are to be in place, functional <u>prior to</u> diversion of any water.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
