SOURCE OF WATER: BEN IRVING RESERVOIR, CONSTRUCTED UNDER PERMIT R-8444, TRIBUTARY OF BERRY CREEK

PURPOSE OR USE: DOMESTIC USE FOR ONE HOUSEHOLD INCLUDING THE IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED ONE-HALF ACRE IN AREA

VOLUME OF USE: 2.0 ACRE-FEET (AF) PER YEAR PER CONTRACT WITH THE LOOKINGGLASS-OLALLA WATER CONTROL DISTRICT

PERIOD OF ALLOWED USE: YEAR ROUND FROM STORED WATER ONLY

DATE OF PRIORITY: MARCH 13, 1991

POINT OF DIVERSION LOCATION: NW 1/4 NW 1/4, SECTION 34, T28S, R7W, W.M.; 2203.5 FEET NORTH AND 1769.9 FEET WEST FROM THE NE CORNER OF DLC 57

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NE 1/4 NW 1/4
SECTION 34
TOWNSHIP 28 SOUTH, RANGE 7 WEST, W.M.

Measurement recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to

submit alternative measuring procedures for review and approval.

- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The use of water under this permit is subject to the terms and conditions of the Agreement for Purchase of Domestic Water or a satisfactory replacement between the Lookingglass-Olalla Water Control District and the applicant, a copy of which is on file in the records of the Water Resources Department.

The permittee shall install, maintain, and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion. The required screens and by-pass devices are to be in place, functional and approved by an ODFW representative prior to diversion of any water.

The permittee shall not construct, operate or maintain any dam or artificial obstruction to fish passage in the channel of the subject stream.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
