PURPOSE OR USE: DOMESTIC USE FOR TWO HOUSEHOLDS INCLUDING IRRIGATION OF ONE-HALF ACRE NON-COMMERCIAL GARDEN FOR EACH HOUSEHOLD AS RESTRICTED BELOW

MAXIMUM FLOW ALLOWED: 0.02 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR DOMESTIC USE FOR EACH HOUSEHOLD INCLUDING ONE-HALF ACRE NON-COMMERCIAL GARDEN AT EACH HOUSEHOLD; AND FURTHER LIMITED TO 0.005 CFS FOR HUMAN CONSUMPTION AT EACH HOUSEHOLD DURING THE PERIOD LISTED BELOW

PERIOD OF USE: DECEMBER 1 THROUGH MAY 31 FOR DOMESTIC USE FOR TWO HOUSEHOLDS INCLUDING IRRIGATION OF ONE-HALF ACRE NON-COMMERCIAL GARDEN FOR EACH HOUSEHOLD; JUNE 1 THROUGH NOVEMBER 30 FOR HUMAN CONSUMPTION ONLY.

DATE OF PRIORITY: MARCH 15, 1989

POINT OF DIVERSION LOCATION: NW 1/4 NW 1/4, SECTION 24, TOWNSHIP 34 SOUTH, RANGE 8 WEST, W.M.; 450 FEET SOUTH AND 572 FEET EAST FROM THE NW CORNER OF SECTION 24

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NE 1/4 NE 1/4 SE 1/4 NE 1/4 SECTION 24 TOWNSHIP 34 SOUTH, RANGE 8 WEST, W.M.

Measurement, recording and reporting conditions:

A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and

shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.

B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The permittee may be required in the future to install, maintain, and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin within one year from permit issuance and shall be completed on or before October 1, 1998. Complete application of the water to the use shall be made on or before October 1, 1999.
