PURPOSE OR USE: DOMESTIC USE EXPANDED FOR ONE HOUSEHOLD AND IRRIGATION OF 13.8 ACRES

RATE OF USE: 0.182 CUBIC FOOT PER SECOND (CFS); BEING 0.01 CFS FOR DOMESTIC USE EXPANDED FOR ONE HOUSEHOLD, AND 0.172 CFS FOR IRRIGATION OF 13.8 ACRES; FURTHER LIMITED TO 0.005 CFS FOR HUMAN CONSUMPTION ONLY AS LISTED BELOW

PERIOD OF ALLOWED USE: SEPTEMBER 16 THROUGH JUNE 15 FOR DOMESTIC USE EXPANDED FOR ONE HOUSEHOLD; MARCH 1 THROUGH JUNE 15 AND SEPTEMBER 16 THROUGH OCTOBER 31 FOR IRRIGATION; FURTHER LIMITED TO 0.005 CFS JUNE 16 THROUGH SEPTEMBER 15 FOR HUMAN CONSUMPTION ONLY

DATE OF PRIORITY: NOVEMBER 14, 1991

POINT OF DIVERSION (POD) LOCATION: NE 1/4 SE 1/4, SECTION 19, T26S, R5W, W.M.; POD 1 - 230 FEET SOUTH AND 1010 FEET WEST, POD 2 - 840 FEET SOUTH AND 1190 FEET WEST, BOTH FROM THE E 1/4 CORNER OF SECTION 19

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NE 1/4 SE 1/4 13.8 ACRES SECTION 19 TOWNSHIP 26 SOUTH, RANGE 5 WEST, W.M.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee shall install, maintain, and operate fish screening to prevent fish from entering the proposed diversion. The permittee shall also install a fishway at the obstruction that will provide adequate upstream and downstream passage for fish. The required screens and fishways are to be in place, functional, and approved by Oregon Department of Fish and Wildlife before diversion of any water. The permittee shall not construct, operate or maintain any dam or artificial obstruction to fish passage in the channel of the North Umpqua River.

## STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
