PURPOSE OR USE: DOMESTIC USE EXPANDED FOR ONE HOUSEHOLD AND MAINTENANCE OF AN UNNAMED RESERVOIR, CONSTRUCTED UNDER APPLICATION R-70779, PERMIT R-11926, FOR FISH HABITAT FROM UNNAMED STREAM 1

RATE OF USE: 0.014 CUBIC FOOT PER SECOND (CFS) FROM UNNAMED STREAM 1 WITH ANY DEFICIENCY TO BE MADE UP FROM UNNAMED STREAM 2, BEING 0.01 CFS FROM UNNAMED STREAM 1 WITH ANY DEFICIENCY TO BE MADE UP FROM UNNAMED STREAM 2 FOR DOMESTIC USE EXPANDED AND 0.004 CFS FOR FISH HABITAT; FURTHER LIMITED TO 0.005 CFS FOR HUMAN CONSUMPTION DURING THE PERIOD LISTED BELOW

PERIOD OF ALLOWED USE: JANUARY 1 THROUGH APRIL 30 FOR DOMESTIC USE EXPANDED AND RESERVOIR MAINTENANCE FOR FISH HABITAT; FURTHER LIMITED FROM MAY 1 THROUGH DECEMBER 31 TO HUMAN CONSUMPTION ONLY

DATE OF PRIORITY: OCTOBER 18, 1990

POINT OF DIVERSION (POD) LOCATION: SW 1/4 NW 1/4, SW 1/4 SW 1/4, SECTION 35, T30S, R7W, W.M.; POD 1: 1750 FEET SOUTH AND 160 FEET EAST; POD 2: 410 FEET NORTH AND 10 FEET EAST, BOTH FROM THE W 1/4 CORNER OF SECTION 35

THE PLACE OF USE IS LOCATED AS FOLLOWS:

Measurement recording and reporting conditions:

A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such

device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

Use under this permit is limited to the reservoir area. This permit does not provide for the appropriation of water for maintaining the water level or maintaining a suitable fresh water condition between July 15 and October 31.

The permittee shall install, maintain, and operate fish screening to prevent fish from entering the proposed diversion. The permittee shall also install a fishway at the obstruction that will provide adequate upstream and downstream passage for fish. The required screens and fishways are to be in place, functional, and approved by Oregon Department of Fish and Wildlife before diversion of any water.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
