PURPOSE OR USE: DOMESTIC USE FOR 11 HOUSEHOLDS INCLUDING IRRIGATION LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED 1/2 ACRE IN AREA FOR EACH, SUPPLEMENTAL DOMESTIC USE FOR 1 HOUSEHOLD INCLUDING IRRIGATION LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED 1/2 ACRE IN AREA; DOMESTIC USE ONLY FOR 11 HOUSEHOLDS AND SUPPLEMENTAL DOMESTIC USE FOR 1 HOUSEHOLD

MAXIMUM RATE/VOLUME ALLOWED: 0.05 CUBIC FOOT PER SECOND (CFS), BEING 0.04 CFS FROM SPRING B, 0.005 CFS FROM SPRING C AND 0.003 CFS FROM SPRING D FOR DOMESTIC USE INCLUDING IRRIGATION LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED 1/2 ACRE IN AREA, AND LIMITED TO A CUMULATIVE TOTAL OF 0.02 CFS FROM ALL THREE SPRINGS AT ANY ONE TIME FOR DOMESTIC USE ONLY

PERIOD OF USE: NOVEMBER 1 THROUGH SEPTEMBER 30 FOR DOMESTIC USE INCLUDING IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED 1/2 ACRE IN AREA AND OCTOBER 1 THROUGH OCTOBER 31 FOR DOMESTIC USE ONLY

POINT OF DIVERSION LOCATION: NW 1/4 NW 1/4, SECTION 33, TOWNSHIP 13 SOUTH, RANGE 10 WEST, W.M.; SPRING 1(B) - SOUTH 45 DEG 50 MIN EAST, 592 FEET; SPRING 2(C) - SOUTH 45 DEG 29 MIN EAST, 593 FEET; SPRING 3(D) - SOUTH 46 DEG 45 MIN EAST, 602 FEET; ALL FROM NW CORNER, SECTION 33, TOWNSHIP 13 SOUTH, RANGE 10 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or

other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.

- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.


The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction of the well shall begin within one year from permit issuance. Complete application of the water to the use shall be made on or before October 1, 2001.
