SOURCE OF WATER: SOUTH UMPQUA RIVER, A TRIBUTARY OF UMPQUA RIVER AND GALESVILLE RESERVOIR, CONSTRUCTED UNDER PERMIT R-9964, A TRIBUTARY OF COW CREEK

PURPOSE OR USE: IRRIGATION OF 80.0 ACRES

MAXIMUM RATE/VOLUME ALLOWED: 1.0 CUBIC FOOT PER SECOND (CFS) OF LIVE FLOW FROM THE SOUTH UMPQUA RIVER AND 178.4 ACRE-FEET PER YEAR OF STORED WATER FROM GALESVILLE RESERVOIR

PERIOD OF USE: MARCH 1 THROUGH JUNE 30 FOR LIVE FLOW AND MARCH 1 THROUGH OCTOBER 31, OR AS FURHTER LIMITED BY CONTRACT FOR STORED WATER

DATE OF PRIORITY: MAY 3, 1996

POINT OF DIVERSION LOCATION: <u>SOUTH UMPOUA DIVERSION</u> - SE 1/4 NE 1/4, SECTION 6, TOWNSHIP 27 SOUTH, RANGE 6 WEST, W.M.; 2200 FEET SOUTH & 600 FEET WEST FROM NE CORNER, SECTION 6 <u>GALESVILLE RESERVOIR</u> - SW 1/4 NE 1/4, SECTION 28, TOWNSHIP 31 SOUTH, RANGE 4 WEST, W.M.; 2920 FEET NORTH & 2060 FEET WEST FROM SE CORNER, SECTION 28

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

THE PLACE OF USE IS LOCATED AS FOLLOWS:

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The permittee shall install, maintain, and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the proposed diversion. The required screens and by-pass devices are to be in place, functional and approved by an ODFW representative prior to diversion of any water.

The use of water under this right is subject to the terms and conditions of contract No. I-96-5 dated April 5, 1996, or a satisfactory replacement, between Douglas County and the applicant, a copy of which is on file in the records of the Water Resources Department.

The use may be restricted if the quality of the source stream, namely the South Umpqua River, decreases to the point that it no longer meets state and federal water quality standards due to reduced flows.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
