SOURCE OF WATER: WADE RESERVOIR, ORIGINALLY CONSTRUCTED UNDER PERMIT R-1716 FOR THE STORAGE OF 645.0 ACRE-FEET, ENLARGED UNDER PERMIT R-2042 FOR THE STORAGE OF AN ADDITIONAL 114.15 ACRE FEET, ADDITIONAL SOURCES ADDED UNDER PERMIT R-2365, R-2706 AND APPLICATION R-80660, PERMIT R-12461, (STORING THE WATERS WASSON CANYON, SPRING CREEK, AND LONG CANYON, TRIBUTARIES OF NORTH FORK LITTLE BUTTE CREEK)

PURPOSE OR USE: IRRIGATION OF 104.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 17.45 ACRES

MAXIMUM VOLUME ALLOWED: 547.44 ACRE-FEET OF STORED WATER EACH YEAR FROM THE 759.15 ACRE-FEET OF WATER AUTHORIZED TO BE STORED ANNUALLY IN WADE RESERVOIR UNDER PERMITS R-1716, R-2042, R-2365, R-2706 AND APPLICATION R-80660, PERMIT R-12461

PERIOD OF USE: APRIL 1 THROUGH SEPTEMBER 30

DATE OF PRIORITY: NOVEMBER 2, 1995

POINT OF DIVERSION LOCATION: SW 1/4 SE 1/4, SECTION 10, T36S, R2E, W.M.; 1020.0 FEET NORTH AND 2540.0 FEET WEST FROM THE SE CORNER OF SECTION 10

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

**STANDARD CONDITIONS**

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.


