SOURCE OF WATER: TWO RESERVOIRS TO BE CONSTRUCTED UNDER PERMIT R-12505,  
TRIBUTARIES OF SIXES RIVER

PURPOSE OR USE: SUPPLEMENTAL CRANBERRY USE ON 57.0 ACRES

MAXIMUM VOLUME ALLOWED: 61.0 ACRE-FEET PER YEAR OF STORED WATER ONLY,  
BEING 55.0 ACRE-FEET FROM RESERVOIR 1 & 6.0 ACRE-FEET FROM RESERVOIR 2

PERIOD OF USE: YEAR ROUND

DATE OF PRIORITY: JULY 25, 1997

POINT OF DIVERSION LOCATION: SW 1/4 SW 1/4, SE 1/4 SW 1/4 SECTION 9,  
T32S, R15W, W.M.; RESERVOIR 1- 1660 FEET SOUTH & 1650 FEET EAST;  
RESERVOIR 2- 1670 FEET SOUTH & 370 FEET EAST ALL FROM W1/4 CORNER,  
SECTION 9

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

## Measurement, recording and reporting conditions:

- A. Before water use may begin under this permit, the permittee shall install a meter or other suitable measuring device as approved by the Director. The permittee shall maintain the meter or measuring device in good working order.
- B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

Before water use may begin under this permit, a totalizing flow meter must be installed at each diversion point. The totalizing flow meter must be installed and maintained as identified in OAR 690-507-645.

**STANDARD CONDITIONS**

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.


By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin by June 8, 1999. Complete application of water to the use shall be made on or before October 1, 2002. Within one year after complete application of water to the proposed use, the permittee shall submit a claim of beneficial use, which includes a map and report, prepared by a Certified Water Rights Examiner (CWRE).
