SOURCE OF WATER: AN UNNAMED SPRING, MCQUE CREEK, AND AN UNNAMED STREAM,
TRIBUTARIES TO THE COQUILLE RIVER

PURPOSE OR USE: LIVESTOCK USE AND DOMESTIC USE FOR THREE HOUSEHOLDS
INCLUDING IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED $\frac{1}{2}$
ACRE IN AREA FOR EACH

MAXIMUM RATE ALLOWED: A CUMULATIVE TOTAL OF NO MORE THAN 0.025 CUBIC
FOOT PER SECOND (CFS) AT ANY ONE TIME, BEING UP TO 0.025 CFS FROM ANY OF
THE THREE SOURCES AND BEING 0.02 CFS FOR DOMESTIC USE FOR THREE
HOUSEHOLDS INCLUDING IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO
EXCEED $\frac{1}{2}$ ACRE IN AREA FOR EACH AND 0.005 CFS FOR LIVESTOCK USE

PERIOD OF USE: YEAR ROUND (AS CONDITIONED BELOW)

DATE OF PRIORITY: DECEMBER 3, 1996

POINT OF DIVERSION LOCATION: NW 1/4 NW 1/4, SW 1/4 NW 1/4, SECTION 14,
T28S, R14W, W.M.; POD 3 - 800 FEET SOUTH AND 120 FEET EAST FROM NW
CORNER, SECTION 14; POD 1 - 440 FEET NORTH AND 230 FEET EAST, POD 2 -
410 FEET NORTH AND 120 FEET EAST BOTH FROM W1/4 CORNER, SECTION 14

THE PLACE OF USE IS LOCATED AS FOLLOWS:

GOV. LOT 1 (NE 1/4 NE 1/4) 2 HOUSEHOLDS & LIVESTOCK
GOV. LOT 2 (SE 1/4 NE 1/4) 1 HOUSEHOLD
SECTION 15
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the permittee to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the permittee to install a meter or other measuring device, the permittee shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the permittee shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the permittee to submit alternative measuring procedures for review and approval.
- B. The Director may require the permittee to keep and maintain a record of the amount (volume) of water used and may require the permittee to report water use on a periodic schedule as established by the Director. In addition, the Director may require the permittee to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the permittee to submit alternative reporting procedures for review and approval.

The use of water allowed herein, August 1 through October 31, may be made only at times when waters from the Unnamed Spring (headwaters of McQue Creek), McQue Creek, and the Unnamed Stream would not under natural conditions flow into the Coquille River or sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

STANDARD CONDITIONS

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.


This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The Director finds that the proposed use(s) of water described by this permit, as conditioned, will not impair or be detrimental to the public interest.

Actual construction work shall begin by May 28, 1999. Complete application of water to the use shall be made on or before October 1, 2002. Within one year after complete application of water to the proposed use, the permittee shall submit a claim of beneficial use, which includes a map and report, prepared by a Certified Water Rights Examiner (CWRE).
