PURPOSE OR USE: HUMAN CONSUMPTION (DRINKING, COOKING, AND SANITATION)

FOR TWO HOUSEHOLDS

MAXIMUM RATE: 0.01 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FOR EACH

HOUSEHOLD

PERIOD OF USE: YEAR ROUND

DATE OF PRIORITY: APRIL 5, 2005

POINT OF DIVERSION (POD) LOCATIONS:

POD 1: NE 4 NE 4 SECTION 25, T24S, R11W, W.M.; 740 FEET SOUTH & 1000 FEET WEST FROM NE CORNER, SECTION 25

POD 2: NE 4 NE 4 SECTION 25, T24S, R11W, W.M.; 600 FEET SOUTH & 900 FEET WEST FROM NE CORNER, SECTION 25

THE PLACE OF USE IS LOCATED AS FOLLOWS:

NE 1 NE 1 SECTION 25

TOWNSHIP 24 SOUTH, RANGE 11 WEST, W.M.

Measurement, recording and reporting conditions:

A. Before water use may begin under this permit, the water user shall install a meter or other suitable measuring device as approved by the Director. The water user shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may

require the water user to report general water use information, including the place and nature of use of water under the permit.

B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall install, maintain, and operate fish screening and by-pass devices consistent with current Oregon Department of Fish and Wildlife (ODFW) standards. Fish screening is to prevent fish from entering the proposed diversion while by-pass devices provide adequate upstream and downstream passage for fish. The required screen and by-pass devices are to be in place and functional <u>prior to</u> diversion of any water. Water user shall obtain written approval from ODFW that the installation of the required screen and by-pass devices meets the state's criteria or the water user shall submit documentation that ODFW has determined screens and/or by-pass devices are not necessary.

## STANDARD CONDITIONS

Where two or more water users agree among themselves as to the manner of rotation in the use of water and such agreement is placed in writing and filed by such water users with the watermaster, and such rotation system does not infringe upon such prior rights of any water user not a party to such rotation plan, the watermaster shall distribute the water according to such agreement.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows, except where those instream water rights allow for the use authorized herein.

Complete application of the water to the use shall be made on or before October 1, 2009. If the water is not completely applied before this date, and the water user wishes to continue development under the permit, the water user must submit an application for extension of time, which may be approved based upon the merit of the application.

Within one year after complete application of water to the proposed use, the water user shall submit a claim of beneficial use, which includes a map and report, prepared by a Certified Water Rights Examiner (CWRE).
