The use to which water is to be applied is Supplemental Irrigation.

## **PERMIT S-55102**

If for irrigation, this appropriation shall be limited to a diversion not to exceed 4.0 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same lands and shall not exceed the limitation allowed herein and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 21, 1963.

Actual construction work shall begin on or before December 2, 1964 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965

Complete application of the water to the proposed use shall be made on or before October 1, 1966
