ABSTRACT MADE

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, C. S. Noblin (Name of Applicant) of Route No. 2, Freewater (Postoffice), County of Umatilla, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is waste water from land of C.L. Ringer which joins me on the east (Name of stream) tributary of (Pine Creek Watershed)

2. The amount of water which the applicant intends to apply to beneficial use is 1/16 (.061) cubic feet per second.

3. The use to which the water is to be applied is irrigation, being a supplemental supply for the irrigation of land already having a partial water right. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located along the east line of S 1/2 NW 1/4 NE 1/4 NE 1/4 of Section 3 Tp. 5 N Range 35 E. W. M. (Give distance and bearing to section corner)

being within the NE 1/4 NE 1/4 of Sec. 3, Tp. 5 N, R. 35 E, W. M., in the county of Umatilla (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The ditch to be 300 feet in length, terminating in the NE 1/4 NE 1/4 of Sec. 3, Tp. 5 N, R. 35 E, W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

STATE OF OREGON, County of Marion, ss.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of waste water from land of C. L. Ringer for a supplemental supply for irrigation purposes, and is also limited to the water available at the proposed point of diversion and does not carry with it the right to divert water from the stream from which the waste water is diverted nor the right to require the wasteful use of water by others.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.06 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 24, 1922.

Actual construction work shall begin on or before July 20, 1923 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1924.

Complete application of the water to the proposed use shall be made on or before October 1, 1925.
