APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, A. V. Schmitt (Name of Applicant) of Kerby (Postoffice), County of Josephine, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Springs & Schmitt's Bayou (Name of stream)

tributary of Deer Creek - Illinois River

2. The amount of water which the applicant intends to apply to beneficial use is 0.08 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located Commencing at the southwest corner of Section 11, thence east 80 rods, thence north 20 rods, thence east 3 rods. (Give distance and bearing to section corner)

being within the SE 1/4 SW 1/4 of Sec. 11, Tp. 38 S (Give smallest legal subdivision) (No. N. or S.)

R. 8 W, W. M., in the county of Josephine (No. E. or W.)

5. The ditch and pipe line to be 330 feet in length, terminating in the SE 1/4 SW 1/4 of Sec. 11, Tp. 38 S (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.)

STATE OF OREGON,) ss. County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Springs & Schmitt's Bayou for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.075 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is December 7, 1922.

Actual construction work shall begin on or before December 18, 1923 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1924

Complete application of the water to the proposed use shall be made on or before October 1, 1925
