APPLICATION FOR A PERMIT

CERTIFICATE NO. 8602

To appropriate the Public Waters of the State of Oregon

I, SUN PORTLAND CEMENT CO., (Name of Applicant) of Lime, County of Baker, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation Nevada, Dec. 18, 1922.

1. The source of the proposed appropriation is Burnt River (Name of stream)

tributary of The Snake River

2. The amount of water which the applicant intends to apply to beneficial use is Three (3) cubic feet per second.

3. The use to which the water is to be applied is Domestic, Mining or manufacturing (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 300 ft. west of the NW corner of the SE 1/4 of the SE 1/4 Sec. 27 Tp. 13 R 44 E.W.M. (Give distance and bearing to section corner)

being within the SW 1/4 or SE 1/4 of Sec. 27, Tp. 13 S, R. 44 E, W. M., in the county of Baker, Oregon. (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The Suction Pipe Line to be 500 feet in length, terminating in the SE 1/4 of SE 1/4 of Sec. 27, Tp. 13, R. 44 E, W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

*This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.*

The right herein granted is limited to the appropriation of water from Burnt River for domestic and mining or manufacturing purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed ..... 3.0 ..... cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is ..... January 16, 1923.

Actual construction work shall begin on or before ..... February 9th, 1924. and shall thereafter be prosecuted with reasonable diligence and be completed on or before ..... June 1, 1925.

Complete application of the water to the proposed use shall be made on or before ..... October 1, 1926.
