APPROPRIATE NO. 5035

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Oregon State Game Commission (Name of Applicant) of Portland (Postoffice), County of Multnomah, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Oak Springs Creek (Name of stream)

tributary of Deschutes River

2. The amount of water which the applicant intends to apply to beneficial use is Three cubic feet per second.

3. The use to which the water is to be applied is for Trout Hatchery (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1000' SW of the NE corner of NE 1/4 of SE 1/4 Sec. 17, Tp 4 R 14 E W M (Give distance and bearing to section corner)

being within the NW 1/4 of SE 1/4 of Sec. 17, Tp. 4 S (Give smallest legal subdivision) (No. N. or S.) R. 14 E, W. M., in the county of Wasco (No. E. or W.)

5. The Pipe Line to be 366' miles (Main ditch, canal or pipe line) in length, terminating in the NW 1/4 of SE 1/4 of Sec. 17, Tp. 4 S (Smallest legal subdivision) (No. N. or S.) R. 14 E, W. M., the proposed location being shown throughout on the accompanying map. (No. E. or W.)

6. The name of the ditch, canal or other works is Oak Springs Hatchery

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Oak Springs Creek for propagating fish.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 3.0 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is January 23, 1923.

Actual construction work shall begin on or before June 6, 1924. and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1925.

Complete application of the water to the proposed use shall be made on or before October 1, 1926.
