APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Jewell H. Gill, of Oswego, Route 1, County of Multnomah, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

1. The source of the proposed appropriation is Springs, No name, in NE 1/4 SW 1/4 & NW 1/4 SE 1/4 Sec. 35 T 1 S R 1 E Willamette Watershed tributary of

2. The amount of water which the applicant intends to apply to beneficial use is 4 gal. per min. 0.01 cubic feet per second.

3. The use to which the water is to be applied is Propagation of fish. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located (Give distance and bearing to section corner)

being within the NE 1/4 SW 1/4 & NW SE of Sec. 35, Tp. 1 S, R. 1 E, W. M., in the county of Multnomah

5. The Pipe line to be 60 ft. in length, terminating in the NW 1/4 SE 1/4 of Sec. 35, Tp. 1 S, R. 1 E, W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from springs

located on NE 1/4 SW 1/4 NW SE Section 35 T 1 S. R. 1 E.W.M. for propagation of fish.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.01 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is February 26, 1924.

Actual construction work shall begin on or before March 22, 1925 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1926 EXTENDED TO 6/1/27 6/1/26

Complete application of the water to the proposed use shall be made on or before October 1, 1927 EXTENDED TO 10/1/26
