APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, R. R. Peters, (Name of Applicant) of Myrtle Creek (Postoffice), County of Douglas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is North Myrtle Creek (Name of stream)

tributary of South Umpqua River

2. The amount of water which the applicant intends to apply to beneficial use is (.037) 3/80 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 13.09 North and 0.46 chains West from the SW cor. of the Henry Jones' D.L.C. No. 48 in Tp. 29 S R 5 W. as in Permit No. 4803, leaving the main ditch in the Morrison place in a westerly direction,

being within the SE 1/4 of SW 1/4 of Sec. 14, Tp. 29 S, R. 5 W, Douglas, W. M., in the county of Douglas (No. E. or W.) (Give smallest legal subdivision) (No. N. or S.)

5. The open ditch to be in length, terminating in the NE quarter of SW 1/4 of Sec. 22, Tp. 29 S, R. 5 W, W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.)

6. The name of the ditch, canal or other works is Peters' extension of North Myrtle Creek Irrigation Ditch.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from
North Myrtle Creek for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.04 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is April 28 1924

Actual construction work shall begin on or before May 31, 1925 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1926

Complete application of the water to the proposed use shall be made on or before October 1, 1927
