APPLICATION FOR A PERMIT

CERTIFICATE NO. 7403

To appropriate the Public Waters of the State of Oregon

I, J. B. Grubb, (Name of Applicant) of Cottage Grove, (Postoffice) County of Lane State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Coast Fork river (Name of stream) tributary of Willamette

2. The amount of water which the applicant intends to apply to beneficial use is 1/8 (.125) cubic feet per second.

3. The use to which the water is to be applied is Irrigation and domestic supply. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 22.16 South and 14.37 East from the Northwest corner of Section 9 Tp. 21 S R 3 W. bearing being S 32° 20' E 26.82 chains distance (Give distance and bearing to section corner)

being within the SW 1/4 of the NW 1/4 of Sec. 9, Tp. 21 S, R. 3 W, W. M., in the county of Lane (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The pipe line to be 545 feet in length, terminating in the SW 1/4 of the NW 1/4 of Sec. 9, Tp. 21 S, R. 3 W, W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

6. The name of the ditch, canal or other works is J. B. Grubb Water System.

STATE OF OREGON,) ss. County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Coast

Fork of Willamette River for irrigation and domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.13 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is October 30, 1924.

Actual construction work shall begin on or before November 21, 1925 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1 1926.

Complete application of the water to the proposed use shall be made on or before October 1, 1927
