APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Fred H. and Mary E. Henrici, (Name of Applicant) Route No. 3, Box 69, Boring, County of Clackamas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

1. The source of the proposed appropriation is An unnamed spring on Lot 2 or the NW 1/4 SE 1/4 of Sec. 4 T 2 S R 3 E. W.M. (Name of stream) tributary of Clackamas River Watershed

2. The amount of water which the applicant intends to apply to beneficial use is 0.1 cubic feet per second.

3. The use to which the water is to be applied is Domestic, including garden irrigation. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from an unnamed spring on Lot 2, or NW 1/4 SE 1/4 of Section 4 T 2 S R 3 E.W.M., for domestic supplies including garden irrigation.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is March 12, 1925.

Actual construction work shall begin on or before March 17, 1926. and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1927

Complete application of the water to the proposed use shall be made on or before October 1, 1928
