APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, C. L. Hazen, (Name of Applicant) of The Dalles, (Postoffice) County of Wasco State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

1. The source of the proposed appropriation is A small spring (Name of stream) tributary of Columbia River (If any it sinks before reaching river.)

2. The amount of water which the applicant intends to apply to beneficial use is One inch pipe (0.1) cubic feet per second.

3. The use to which the water is to be applied is Domestic supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located Commencing at Sect. corner 29, running South, (Give distance and bearing to section corner) on Sect. line 264 feet then West 190 feet to spring.

STATE OF OREGON, } ss. County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from an unnamed spring for domestic supply

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is March 21, 1925.

Actual construction work shall begin on or before May 1, 1926 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1927

Complete application of the water to the proposed use shall be made on or before October 1, 1928
