

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Kissinger and Eldredge (Name of applicant) of Glendale (Postoffice), County of Douglas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

- 1. The source of the proposed appropriation is Unnamed Spring (Name of stream), tributary of Cow Creek Watershed.
2. The amount of water which the applicant intends to apply to beneficial use is amount to fill 3/4" pipe (0.1 second foot) cubic feet per second.
3. The use to which the water is to be applied is Domestic supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)
4. The point of diversion is located approximately 3/4 miles S.E. of the N.W. corner (Give distance and bearing to section corner) of Sec. 29, T. 32 R. 5 W. of W.M.

being within the NE 1/4 of SW 1/4 of Sec. 29, Tp. 32 S., R. 5 W., W. M., in the county of Douglas

- 5. The 3/4" pipe line (Main ditch, canal or pipe line) to be 1400 ft. miles in length, terminating in the SE 1/4 of NW 1/4 of Sec. 29, Tp. 32 R. 5 W., W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from an unnamed spring for domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is August 18, 1925

Actual construction work shall begin on or before October 15, 1926 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1927

Complete application of the water to the proposed use shall be made on or before October 1, 1928
