APPLICATION FOR A PERMIT

ABSTRACT MADE

To Appropriate the Public Waters of the State of Oregon

I, W. J. Beardsley (Name of applicant) of Route 1, Rogue River (Postoffice), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Green Canyon, trib. of Evans Creek (Name of stream), tributary of Rogue River.

2. The amount of water which the applicant intends to apply to beneficial use is 0.05 cubic feet per second.

3. The use to which the water is to be applied is Domestic and Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located N. 65° West 700 feet from cor. bet. Secs. 11 and 14, Tp. 35 S. R. 4 W.W.M. (Give distance and bearing to section corner)

being within the SE 1/4 SW 1/4 of Sec. 11, Tp. 35 S, R. 4 W. (Give smallest legal subdivision) (No. N. or S.)

W. M., in the county of Jackson (No. E. or W.)

5. The ditch (Main ditch, canal or pipe line) to be 1/4

miles in length, terminating in the SW 1/4 SW 1/4 of Sec. 11, Tp. 35 S, R. 4 W. (Smallest legal subdivision) (No. N. or S.)

W. M., the proposed location being shown throughout on the accompanying map. (No. E. or W.)

6. The name of the ditch, canal or other works is Beardsley Ditch

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Green Canyon, tributary of Evans Creek, for domestic and irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.05 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is February 25, 1926.

Actual construction work shall begin on or before March 10, 1927 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1928

Complete application of the water to the proposed use shall be made on or before October 1, 1929
