APPLICATION FOR A PERMIT

CERTIFICATE NO. 7119

To Appropriate the Public Waters of the State of Oregon

I, J. P. Binford (Name of applicant) of Freewater, R.F.D.#2 (Postoffice), County of Umatilla, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Dugger Creek (Name of stream), tributary of Pine Creek

2. The amount of water which the applicant intends to apply to beneficial use is 1/8 (.125) cubic feet per second.

3. The use to which the water is to be applied is Irrigation and Stock Water (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located about 1/2 mile South and 600 feet East of the center of Sec. 30. (Give distance and bearing to section corner)

being within the NW 1/4 SE 1/4 of Sec. 30, Tp. 6 N, R. 35 E, W. M., in the county of Umatilla (No. E. or W.) (Give smallest legal subdivision) (No. N. or S.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eighth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Dugger Creek for irrigation and stock watering purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.125 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is April 8, 1926.

Actual construction work shall begin on or before April 16, 1927 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1928

Complete application of the water to the proposed use shall be made on or before October 1, 1929
