APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, J. L. Freiman (Name of applicant) of 101 12th St., Portland (Postoffice), County of Multnomah, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed Springs (Name of stream), tributary of Deep Creek (Clackamas Watershed)

2. The amount of water which the applicant intends to apply to beneficial use is 0.10 cubic feet per second.

3. The use to which the water is to be applied is Domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 178 feet South and 1390 feet West from the center of Section 15 T. 2 S. R. 3 E.W.M. (Give distance and bearing to section corner)

being within the NW 1/4 SW 1/4 of Sec. 15, Tp. 2 S, R. 3 E, W. M., in the county of Clackamas (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The 1 inch pipeline (Main ditch, canal or pipe line) to be 1500 feet miles in length, terminating in the SE 1/4 SW 1/4 of Sec. 15, Tp. 2 S, R. 3 E, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited

to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from an unnamed Spring, a tributary to Deep Creek, a tributary of the Clackamas River, for domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is July 17, 1926

Actual construction work shall begin on or before August 7, 1927 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1928

Complete application of the water to the proposed use shall be made on or before October 1, 1929
