APPLICATION FOR A PERMIT

CERTIFICATE NO. 9197

To Appropriate the Public Waters of the State of Oregon

I, A. T. CLINE (Name of applicant) of Gervais R. #1 (Postoffice), County of Marion, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

1. The source of the proposed appropriation is Pudding River (Name of stream), tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is .31 cubic feet per second.

3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located at various places along the river (Give distance and bearing to section corner) Water is to be pumped from about four places and will be raised to a height of several feet and allowed to drain back toward the river, mostly within

5. The pipe line and ditch to be several pipes 400 to 500 ft. (Main ditch, canal or pipe line) miles in length, terminating in the W 1/4 & NW 1/4 of Sec. 8, Tp. 6 S., R. 1 W., W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Pudding River, a tributary of Willamette River, for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed .31 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is July 21, 1926

Actual construction work shall begin on or before September 10, 1927 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1928

EXTENDED TO 6/1/29

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1929
