

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Fish Commission, State of Oregon. (Name of applicant)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

2. The amount of water which the applicant intends to apply to beneficial use is 10.0

3. The use to which the water is to be applied is supply for fish ponds, and at times to divert the entire unappropriated flow from flowing into said fish ponds, by means of flumes and ditch, into Furrricane Creek. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Spring Creek for supply for fish ponds, and to the appropriation for propagation of fish of the water stored in such ponds under Reservoir Permits Nos. R591 and R592.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 10.0 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 23, 1924.

Actual construction work shall begin on or before March 15, 1928 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1929

Complete application of the water to the proposed use shall be made on or before October 1, 1930.
