

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Larry Lucas (Name of applicant) of Agness (Postoffice), County of Curry, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is No Name (Name of stream), tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 1/12 one twelfth cubic feet per second.

3. The use to which the water is to be applied is irrigation and domestic use (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located N. 38° 49' W. 1422 feet from the corner to Secs. 12, 13, 7 and 18 Tps. 35 S. Rs. 11 and 12 W. W. M. (Give distance and bearing to section corner)

being within the Lot No. 1 of Sec. 12, Tp. 35 S., R. 12 W., W. M., in the county of Curry. (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The pipe line to be 0.794 miles in length, terminating in the Lot No. 4 of Sec. 13, Tp. 35 S., W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

6. The name of the ditch, canal or other works is Last Chance pipe line

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right granted herein is limited to the appropriation of water from an Unnamed Stream, tributary of Rogue River, for irrigation and domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.15 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 7, 1927

Actual construction work shall begin on or before July 8, 1928, and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1929.

Complete application of the water to the proposed use shall be made on or before October 1, 1930.
