

APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, L. W. Smith (Name of applicant) of Payette, Idaho (Postoffice), County of Malheur, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Shephards Gulch (Name of stream)

tributary of Snake River

2. The amount of water which the applicant intends to apply to beneficial use is

two and one-half cubic feet per second.

3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located East 450', North 200' of Southwest (Give distance and bearing to section corner)

corner, of the NE 1/4 of NW 1/4, Sec. 14 Twp. 16 S. R. 47 E. W. M.

being within the NE 1/4 of NW 1/4 (Give smallest legal subdivision) of Sec. 14, Tp. 16 S., R. 47 E., W. M., in the county of Malheur (No. E. or W.)

5. The Ditch (Main ditch, canal or pipe line) to be 3/4

miles in length, terminating in the NW 1/4 SE 1/4 (Smallest legal subdivision) of Sec. 10, Tp. 16 S., R. 47 E., W. M., the proposed location being shown throughout on the accompanying map. (No. E. or W.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Shephard's Gulch for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1.6 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 26, 1927.

Actual construction work shall begin on or before September 1, 1928 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1929.

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1930.
