APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, D. J. Puckett (Name of applicant) of Rocky Point (Postoffice), County of Klamath, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Klamath River (Name of stream), tributary of

2. The amount of water which the applicant intends to apply to beneficial use is one and three tenths (1.3) cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located N. 85 22' W. 6.75 chains from the one quarter corner on the south line of Section 31, T. 39 S., R. 8 E., W.M. (Give distance and bearing to section corner)

The main ditch and pipe line to be approximately one half miles in length, terminating in the lot 2 & lot 3 of Sec. 31, Tp. 39 S., R. 8 E., W.M., the proposed location being shown throughout on the accompanying map. This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Klamath River for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1.3 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is June 23, 1926.

Actual construction work shall begin on or before February 28, 1929 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930.

Complete application of the water to the proposed use shall be made on or before October 1, 1931.
