#### APPLICATION FOR A PERMIT

## TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF OREGON

- We, Frank Heiney, Hannah M. Heiney, and Richard Heiney, of Gresham, County of Multnomah, and State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:
- 1. The source of the proposed appropriation is a large spring, known as the 'HEINEY SPRING' and seepage water passing through a gulch near said Spring, and all of which is tributary to the Willamette River.
- 2. The amount of water which the applicants intend to apply to beneficial use is two
  (2) cubic feet per second.
- 3. The use to which the water is to be applied is for domestic use and for irrigation on a small scale.
  - 4. The point of diversion is located as follows:

587.7 feet South and 222.2 feet West
of the Northeast corner of the Southwest Quarter of the Northeast Quarter
of Section 21, Township 1 South, Range
3 East of the Willamette Meridian, and
of the seepage water is 789.2 feet South
and 139 feet West of the Northeast corner of the Southwest Quarter of the Northeast Quarter of Section 21, Township 1
South, Range 3 East of the Willamette Meridian, being within the Southwest Quarter
of NE4 of Section 21, Township 1 South,
Range 3 East of the Willamette Meridian,
in the County of Multnomah, State of Oregon.

- 5. The proposed pipe line conveying water to be approximately 2000 feet in length, terminating in the Northwest Quarter of Section 21, Township 1 South, Range 3 East of the Willamette Meridian, Multnomah County, Oregon, as indicated on the accompanying map.
- 6. The name of the ditch, canal or other works is (No name given as this is a private domestic water system.)

# DESCRIPTION OF WORKS

### DIVERSION WORKS-

7. (a) Height of dam not to exceed two (2) feet, and of wood construction. The water from these springs has been used for domestic use, irrigation and a log pond and for sawmill purposes for the past twenty-five years, and supplies the applicants and several neighbors

for domestic and house use and for irrigation on a small scale.

(b) Description of headgate (None required).

# CANAL SYSTEM--

8. None other than wood or iron pipe sufficient to convey the flow of these springs.

### IRRIGATION--

9. The land to be irrigated consists of garden plots located in the Northwest Quarter of Section 21, Township 1 South, Range 3 East of the Willamette Meridian, Multnomah County, Oregon.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer The right herin granted is limited to the appropriation of water from Heiney Spring and seepage water passing through a gulch near said spring for domestic purposes including garden irrigation.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equibalent in case of rotation. The priority date of this permit is April 6, 1927.

Actual construction work shall begin on or before April 12, 1929, and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930.

Complete application of the water to the proposed use shall be made on or before October 1, 1931.
