

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, City of Wallowa (Name of applicant) of Wallowa (Postoffice), County of Wallowa, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation Municipal Corporation

1. The source of the proposed appropriation is Bear Creek (Name of stream), tributary of Wallowa River

2. The amount of water which the applicant intends to apply to beneficial use is three (3) cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located SE 1/4 of SW 1/4 Section 22 (Give distance and bearing to section corner)

being within the SE 1/4 of SW 1/4 of Sec. 22, Tp. 1 North, R. 42 East, W. M., in the county of Wallowa (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The small ditches (Main ditch, canal or pipe line) to be a total of One-half miles in length, terminating in the North 1/2 of SW 1/4 of Sec. 15, Tp. 1 North, R. 42 East, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

6. The name of the ditch, canal or other works is Chamberlain

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Bear Creek for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1.65 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is April 2, 1928

Actual construction work shall begin on or before April 12, 1929 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1931
