

APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Oregon State Game Commission (Name of applicant) of Portland (Postoffice), County of Multnomah, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is East Creek and West Creek (Name of stream), tributary of South Coos River

2. The amount of water which the applicant intends to apply to beneficial use is three cubic feet per second. 1.5 sec. ft. from each stream

3. The use to which the water is to be applied is Trout Hatchery (Irrigation, power, mining, manufacturing, domestic supplies, etc.) and feeding pounds

4. The point of division is located No. 1 NE corner Lot 3, Sec. 23, Tp. 25 S, R 11 W. W. M. (Give distance and bearing to section corner) No. 2, In Lot No. 2, Sec. 23, T. 25 S., R. 11 W., W. M.

being within the Lots Nos. 2 and 3 of Sec. 23, Tp. 25 S, R. 11 W, W. M., in the county of Coos (Give smallest legal subdivision) (No. N. or S.)

5. The Fence to be 350' (Main ditch, canal or pipe line)

in length, terminating in the Lot No. 3 of Sec. 23, Tp. 25 S, R. 11 W, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (No. N. or S.)

6. The name of the ditch, canal or other works is Marshfield Hatchery

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from East Creek and West Creek for trout hatchery and feeding ponds.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 3.0 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is July 20, 1925

Actual construction work shall begin on or before April 24, 1929 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1931
