

# To Appropriate the Public Waters of the State of Oregon

I, Dexter Sparks, Frank C. Sparks, and Manena Sparks Schwering  
(Name of applicant)  
of Blue River (Postoffice), County of Lane  
State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Sparks Creek  
(Name of stream), tributary of McKenzie River

2. The amount of water which the applicant intends to apply to beneficial use is 0.6 cubic feet per second.

3. The use to which the water is to be applied is Irrigation and Domestic Use.  
(Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located No. 1--Approximately 300 ft. North and 300 ft. West  
(Give distance and bearing to section corner) of the SE corner of the NW $\frac{1}{4}$  SE $\frac{1}{4}$  and No. 2--Approximately 200 ft. North and 300 ft. West of the SE corner of the SW $\frac{1}{4}$  SE $\frac{1}{4}$

being within the NW $\frac{1}{4}$  SE $\frac{1}{4}$  and SW $\frac{1}{4}$  SE $\frac{1}{4}$  of Sec. 20, Tp. 16 S.  
(Give smallest legal subdivision) (No. N. or S.)  
R. 4 E., W. M., in the county of Lane  
(No. E. or W.)

5. The pipe line to be 1200 feet miles in length, terminating in the SE $\frac{1}{4}$  SE $\frac{1}{4}$  of Sec. 20, Tp. 16 S.  
(Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.)  
R. 4 E., W. M., the proposed location being shown throughout on the accompanying map.  
(No. E. or W.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Sparks Creek for irrigation and domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.15 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is May 9, 1928.

Actual construction work shall begin on or before May 28, 1929, and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930.

Complete application of the water to the proposed use shall be made on or before October 1, 1931.
