APPLICATION FOR A PERMIT

CERTIFICATE NO. 9716

To appropriate the Public Waters of the State of Oregon

I, Charles E. Wilson & Pearle Wilson (Name of applicant) of Roseburg (Postoffice), County of Douglas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is South Branch of South Deer Creek (Name of stream), tributary of Deer Creek and South Umpqua

2. The amount of water which the applicant intends to apply to beneficial use is 0.14 cubic feet per second.

3. The use to which the water is to be applied is Irrigation and Domestic Supply (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of division is located S 33° 17' E 716.6 ft. and S 22° 29' E 632.2 ft. (Give distance and bearing to section corner)

being within the NW 1/4 NW 1/4 of Sec. 5, Tp. 28 S, R. 4 W, W. M., in the county of Douglas

5. The Ditch to be 500 ft. (Main ditch, canal or pipe line) miles/in length, terminating in the NE 1/4 NE 1/4 of Sec. 6, Tp. 28 S, R. 4 W, W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is Chas. E. Wilson Irrigation Ditch

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from South Branch of South Deer Creek for irrigation and domestic purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.14 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is June 16, 1928

Actual construction work shall begin on or before June 28, 1929 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1930. Extended to Oct. 1, 1932

Complete application of the water to the proposed use shall be made on or before October 1, 1931 Extended to Oct. 1, 1932
