

*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, J. L. Ragsdale (Name of applicant) of Trail (Postoffice), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Days Creek (Name of stream), a tributary of Trail Creek

2. The amount of water which the applicant intends to apply to beneficial use is 5/100 cubic feet per second. 4/100 from one source and 1/100 from another (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 82 ft. (N. or S.) and 2194 ft. (E. or W.) from the NE corner of Sec. 25 (Section or subdivision) (If preferable, give distance and bearing to Sec. Cor.)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed .05 cubic feet per second, or its equivalent in case of rotation with other water users, from Days Creek, tributary of Trail Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 22, 1929

Actual construction work shall begin on or before April 24, 1930 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1931

Complete application of the water to the proposed use shall be made on or before October 1, 1932
