

*APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, J. A. Thompson (Name of applicant) of Blodgett (Postoffice), County of Benton, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Marys's River (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 0.02 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is Domestic supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 100 ft. N. and 100 ft. E. from the SE corner of J. A. Thompson property said corner is located twenty-five chains & 50 links south & seven chains & seventeen links west of 1/4 section corner on line between Secs. 22 and 23 (If there are more than one points of diversion, each must be described. Use separate sheet if necessary)

being within the SE 1/4 of Sec. 22, Tp. 11 S. R. 7 W., W. M., in the county of Benton (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The Pipe line to be 400 ft. in length, terminating in the NE 1/4 of Sec. 22, Tp. 11 S. R. 7 W., W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (No. miles or feet) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic feet per second, or its equivalent in case of rotation with other water users, from Marys River

The use to which this water is to be applied is Domestic

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 22, 1929

Actual construction work shall begin on or before September 26, 1930 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1931

Complete application of the water to the proposed use shall be made on or before October 1, 1932
