\*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, J. E. Wolters (Name of applicant) of Newberg, Oregon (Postoffice), County of Yamhill, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed ...0.19... cubic feet per second, or its equivalent in case of rotation with other water users, from ...Unnamed Creek, tributary of Willamette River.....
