...the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The water to be granted is limited to the amount of water which can be applied to beneficial use and ... cubic feet per second measured at the point of diversion from the well or ... or its equivalent in case of rotation with other water users, from three wells

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second ... its equivalent for each acre irrigated and shall be further limited to a diversion ... not to exceed 1/2 acre foot per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be so cased as to prevent the loss of underground water.

The priority date of this permit is February 25, 1952

Actual construction work shall begin on or before November 28, 1953 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1954

Complete application of the water to the proposed use shall be made on or before October 1, 1955
