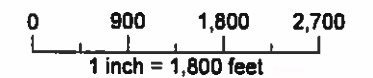

 Well 8 Located 2250 feet North and 1590 feet East from the SW corner of Section 8, Township 5 South, Range 1 West (W.M.)
 Well 9 Located 1200 feet South and 1980 feet East from the NW corner of Section 7, Township 5 South, Range 1 West (W.M.)
 Well 10 Located 1200 feet North and 1720 feet West from the E 1/4 corner of Section 8, Township 5 South, Range 1 West (W.M.)
 Well 11 Located 1840 feet South and 920 feet East from the NW corner of Section 7, Township 5 South, Range 1 West (W.M.)
 Well 12 Located 2466 feet North and 1835 feet West from the SE corner of Section 13, Township 5 South, Range 2 West (W.M.)
 Well 13 Located 1415 feet South and 1155 feet East from the NW corner of Section 18, Township 5 South, Range 1 West (W.M.)
 Well 14 Located 1117 feet North and 35 feet West from the SE corner of Section 5, Township 5 South, Range 1 West (W.M.)

 New Well Site Option B Located 900 feet South and 260 feet West from the NE corner of Section 14, Township 5 South, Range 2 West (W.M.)
 New Well Site Option C Located 2715 feet South and 850 feet East from the NW corner of Section 13, Township 5 South, Range 2 West (W.M.)
