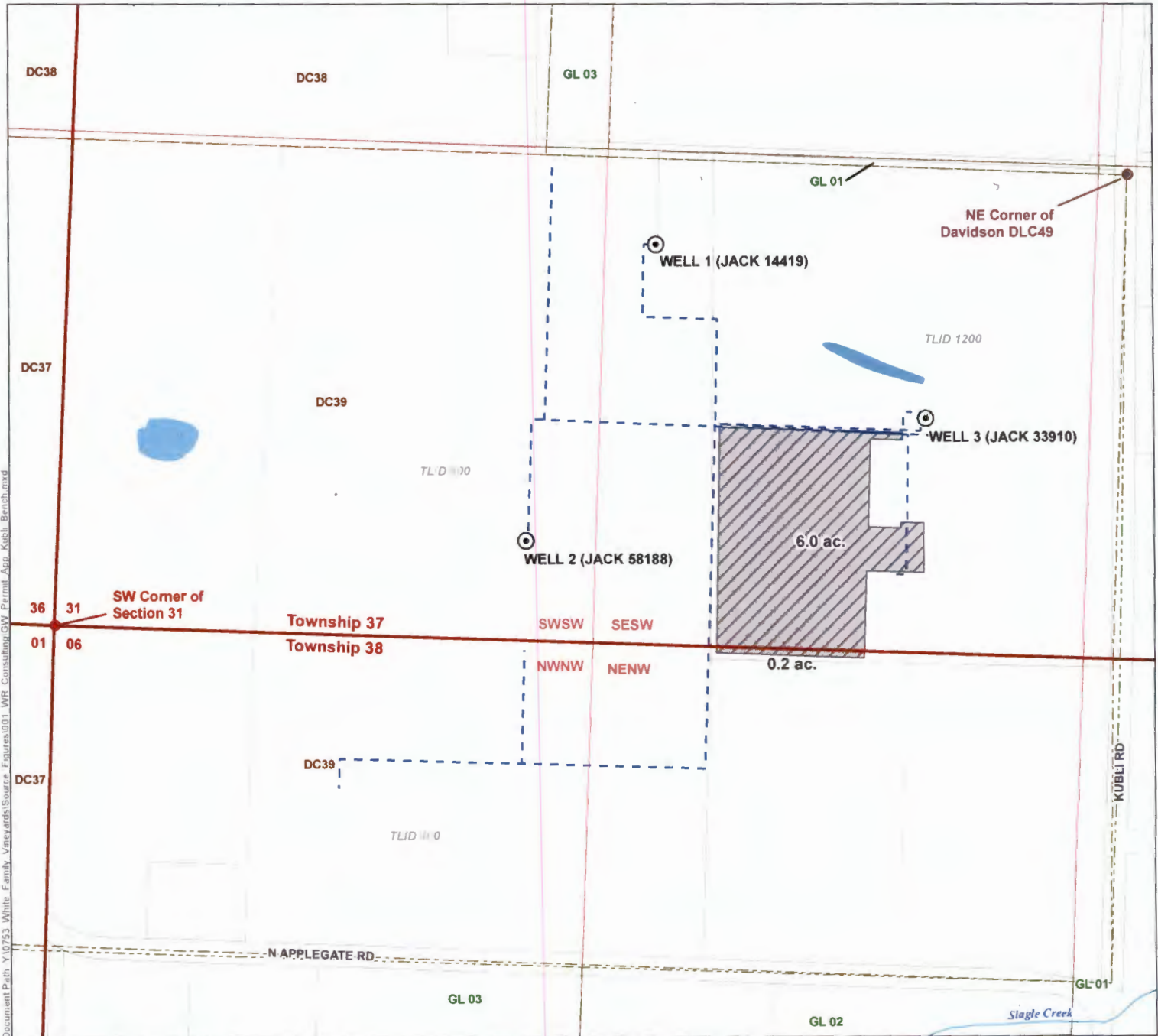

- Well 2 (Jack 58188):** Located 270 feet North and 1,280 feet East from the SW corner of Section 31, Township 37 South, Range 4 West (W.M.)
- Well 3 (Jack 33910):** Located 680 feet South and 540 feet West from the NE corner of Davidson DLC39, Section 31, Township 37 South, Range 4 West (W.M.)
