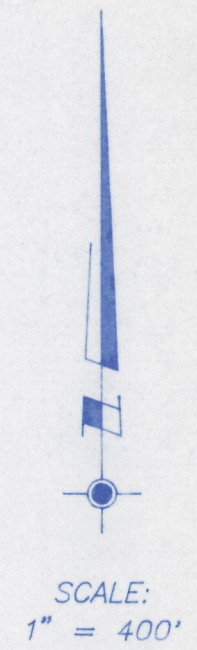

The purpose of this application is to apply for 4.5 Acres of water rights in conjunction with a reservoir permit application. Note: There is a pond registration (P-82747) on file for the five ponds and one sump pond shown on this water right application.

This plat was prepared for the purpose of identifying the location of the water rights only. There is no intent to provide dimensions or locations of property ownership lines.
