KNOW ALL MEN BY THESE PRESENTS, THAT THE HIBERNIA SAVINGS BANK, A CORPORATION, DULY INCORPORATED, ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF OREGON, DOES HEREBY GRANT AND DEDICATE TO THE PUBLIC, THE USE OF THE STREETS ON THE ACCOMPANYING PLAT OF A RE-SURVEY OF MILWAUKIE PARK, MORE PARTICULARLY DESCRIBED AS FOLLOWS--

KELLOGG DONATION LAND CLAIM AND WHICH STONE IS ALSO THE NORTHEAST CORNER OF THE CROWN DONATION LAND CLAIM IN TOWNSHIP TWO (2) SOUTH, RANGE ONE (1) EAST OF THE WILLAMETTE MERIDIAN, RUNNING THENCE FROM POINT OF BEGINNING NORTH 89° 13 MINUTES EAST 250 FEET TO THE WEST LINE OF LOT TWO (2) BLOCK C, MILWAUKIE PARK, THENCE SOUTH ONE DEGREE 1 MINUTE WEST 215 FEET, THENCE SOUTH 46 MINUTES WEST 218 FEET TO THE SOUTHWEST CORNER OF LOT THREE (3), BLOCK C, THENCE NORTH 89 DEGREES 13 MINUTES EAST 200 FEET, THENCE SOUTH 46 MINUTES WEST 218 FEET, THENCE NORTH 89 DEGREES 13 MINUTES EAST 250 FEET, THENCE SOUTH 46 MINUTES WEST 654 FEET, THENCE NORTH 89 DEGREES 13 MINUTES EAST 200 FEET, THENCE SOUTH 46 MINUTES WEST 218 FEET, TO THE SOUTHWEST CORNER OF LOT THIRTEEN (13) BLOCK D, THENCE NORTH 89 DEGREES 13 MINUTES EAST 250 FEET TO THE WEST LINE OF BLOCK E, THENCE SOUTH 46 MINUTES WEST 218 FEET TO THE NORTHWEST CORNER OF LOT SEVEN (7) BLOCK E, THENCE NORTH 89 DEGREES 13 MINUTES EAST 200 FEET, THENCE SOUTH 46 DEGREES WEST 218 FEET, THENCE NORTH 89 DEGREES 13 MINUTES EAST 250 FEET, THENCE SOUTH 46 MINUTES WEST 712.97 FEET TO THE SOUTH LINE OF THE JOS. KELLOGG DONATION LAND CLAIM, THENCE EASTERLY ALONG THE SOUTH LINE OF THE JOS. KELLOGG DONATION LAND CLAIM TO THE SOUTHEASTERLY CORNER THEREOF, THENCE NORTHERLY ON THE EASTERLY LINE OF THE JOS. KELLOGG DONATION LAND CLAIM TO THE CENTER LINE OF KELLOGG CREEK, THENCE DOWN THE CENTER LINE OF KELLOGG CREEK TO A POINT WHICH BEARS NORTH 89 DEGREES 13 MINUTES EAST 1374 FEET THE STONE AT A CORNER OF THE JOS. KELLOGG DONATION LAND CLAIM AND WHICH IS ALSO THE NORTHEAST CORNER OF THE CROWN DONATION LAND CLAIM, THENCE SOUTH 89 DEGREES 13 MINUTES WEST 514 FEET TO THE CENTER OF RIVERSIDE ROAD, THENCE NORTH 47 DEGREES 43 MINUTES WEST 238.5 FEET, THENCE NORTH 47 DEGREES 13 MINUTES WEST 314 FEET, THENCE NORTH 46 DEGREES 44 MINUTES WEST 93.86 FEET TO THE CENTER LINE OF PARK AVENUE IN MILWAUKIE PARK IF PRODUCED EASTERLY, THENCE SOUTH 89 DEGREES 13 MINUTES WEST 385.3 FEET, THENCE NORTH 28 DEGREES 30 MINUTES WEST TO THE CENTER LINE OF EIGHTEENTH STREET IN MILWAUKIE PARK IF PRODUCED NORTHERLY, THENCE NORTH 1 DEGREE 1 MINUTE EAST TO A POINT 295.75 FEET NORTHERLY FROM THE SOUTHERLY LINE OF BLOCK THIRTEEN (13), THENCE SOUTH 89 DEGREES 13 MINUTES WEST 30 FEET, THENCE NORTH 1 DEGREE 1 MINUTE EAST 104.25 FEET, TO THE NORTHEAST CORNER OF BLOCK THIRTEEN (13), MILWAUKIE PARK, THENCE SOUTH 89 DEGREES 13 MINUTES WEST 200.16 FEET, THENCE SOUTH 1 DEGREE 1 MINUTE WEST 400 FEET TO THE SOUTHWEST CORNER OF BLOCK THIRTEEN (13), THENCE NORTH 89 DEGREES 13 MINUTES EAST 203.70 FEET, THENCE SOUTH 28 DEGREES 30 MINUTES EAST TO THE WESTERLY LINE OF LOT TWO (2), BLOCK B, MILWAUKIE PARK, IF PRODUCED NORTHERLY, THENCE SOUTH 1 DEGREE 1 MINUTE WEST 215 FEET TO THE NORTHWEST CORNER OF LOT TWO (2), BLOCK B, AND PLACE OF BEGINNING, SAID LANDS BEING SITUATED IN THE COUNTY OF CLACKAMAS AND STATE OF OREGON.

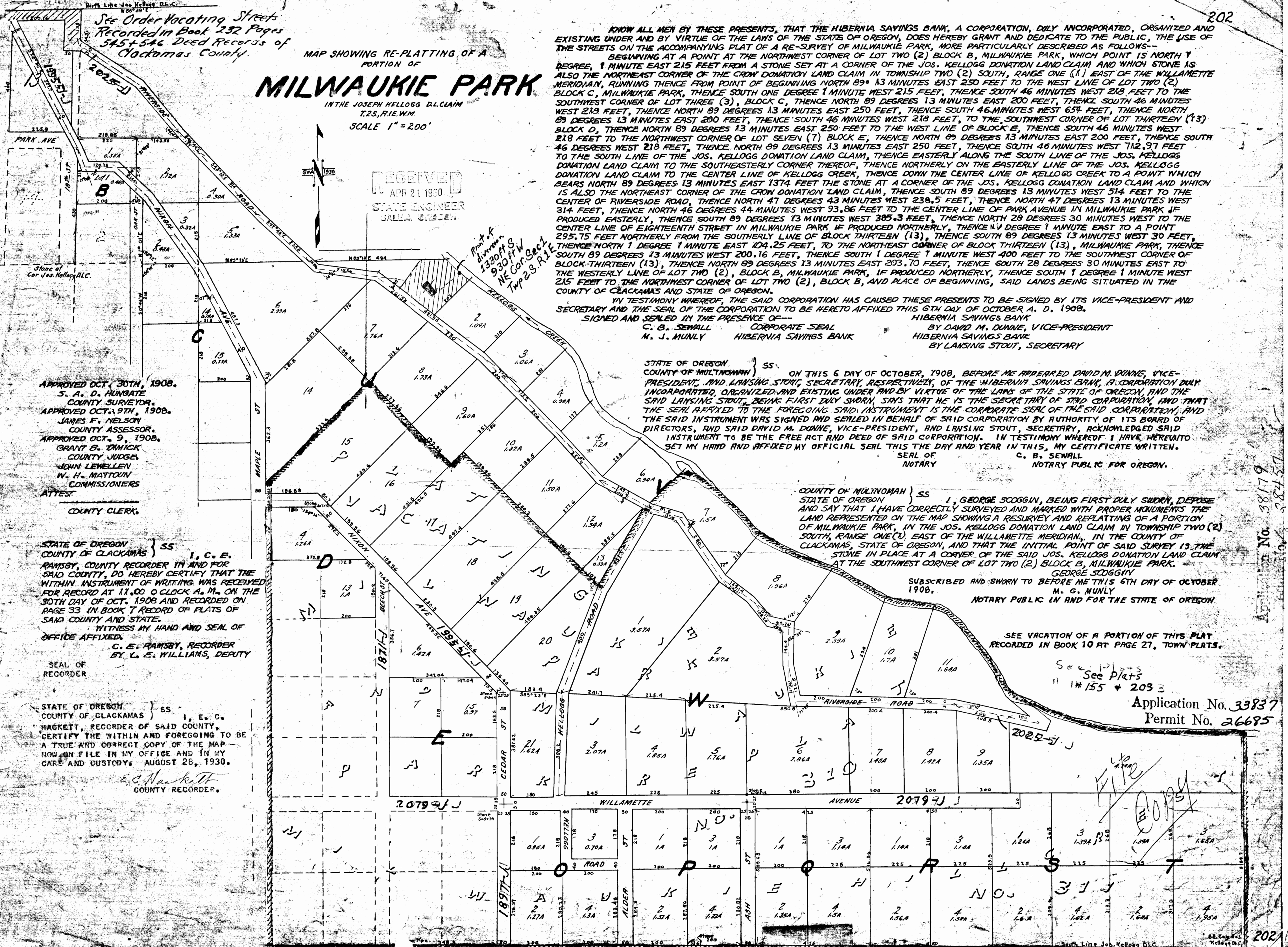
